Fast Days: On fast days, we abstain from (a) all vertebrate products, including meat, dairy items, and fish (by "fish" we mean vertebrate fish; shellfish may be consumed on any day), (b) olive oil, and (c) wine (all alcohol).

Weekly Fast Days: According to the ancient tradition of the Orthodox Church, we fast on Wednesdays to recall the betrayal of Judas and on Fridays to recall the crucifixion of the Lord. Fast Day On certain major feast days, the Fast is relaxed to consume fish, olive oil, and wine.

Fast Free Week: According to our tradition, the week following the Sunday of the Publican and the Pharisee is fast free.
